

1. PREFACE

- 1.1. This website is offered by Avonic B.V., located at Exportweg 11a in Delfgauw and registered with the Chamber of Commerce under number 63411148.
- 1.2. Avonic B.V. can be reached at the above address, as well as by e-mail (info@avonic.com) and telephone (+31 15 711 2712).
- 1.3. This statement is intended to inform you about the processing of your personal data in the context of your use of the Avonic website (hereinafter: Website). In connection with these processing operations, Avonic is the "controller" within the meaning of the General Data Protection Regulation.

2. PURPOSES FOR THE PROCESSING OF PERSONAL DATA

- 2.1. We process the following personal data on the website:
 - First and last name;
 - E-mail address;
 - Phone number (optional).
- 2.2. We process your personal data for the following purposes and based on the following principles:
 - to keep in touch with you. For example, in response to a question you ask via our contact form or to implement a customer relationship with you (basis: execution or preparation of an agreement, or a legitimate interest);
 - To send you current messages. You will then receive mailings regarding Avonic news or developments regarding our products and future events, with an advertising purpose (basis: depending on the situation: permission or legitimate interest). If you no longer wish to receive these messages, you can unsubscribe via the link at the bottom of those messages;
 - To handle any disputes.

3. COOKIES

- 3.1. On the Website we use techniques that can read information from your peripheral equipment or store it on your peripheral equipment (hereinafter: cookies).
- 3.2. First of all, we use functional cookies for the basic functionality of the Website and to store your cookie preferences.
- 3.3. In addition, we use cookies to keep track of your behavior on this Website. For example, we can keep statistics about how many visitors the Website gets, and which pages are viewed the most. We use a cookie from Google to track statistics, as part of the "Analytics" service. This includes, for example, statistical information about the numbers of visitors, the most visited pages and the duration of the visit.

4. RETENTION PERIODS

- 4.1. Avonic will not keep your personal data for longer than is necessary for the purposes for which it was collected.
- 4.2. Your personal data may be kept for longer insofar as this is necessary to comply with legal obligations, such as fiscal retention periods. Or if this is necessary for handling disputes and proceedings.

5. RECEIVERS

- 5.1. Avonic shares your personal data with external service providers such as processors and subcontractors. This includes parties within the transport chain. We also use external service providers to host your personal data. These service providers may receive and/or process your

personal data insofar as this is necessary for the performance of their tasks in the assignment that we provide to them.

6. YOUR RIGHTS

- 6.1. You have the right to request access to and correction, deletion and blocking of your personal data, or to object to the processing. In addition, you are entitled to data portability under certain circumstances.
- 6.2. You also have the right to submit a complaint to the Dutch Data Protection Authority.
- 6.3. In cases where a processing of your personal data is based on your consent, you have the right to withdraw this consent at any time. This does not affect the lawfulness of the consent-based processing that took place before this withdrawal.
